

**Official Rules (“Rules”) for the American Legion Riders Post 91 “Win a RideNow Motorsport” 2024 Drawing (“Drawing”) in December 2024. .**

This motorcycle raffle is a fund-raiser being conducted by the American Legion Riders of Post 91 (ALR 91). All proceeds from the entries will be used to support Veterans, Veteran charities and American Legion Programs. American Legion Riders of Post 91 (ALR 91) is an entity of the Wayne V. McMartin American Legion Post 91 (American Legion Post 91), located 922 North Alma School Road in Chandler, Arizona 85225. A 501(c) organization.

**ELIGIBILITY:** This Drawing is open to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older at the time of the Drawing. Void where prohibited by law.

**HOW TO ENTER:** A raffle ticket (entry) may not be tax deductible as a contribution to American Legion Riders Post 91. Ask your tax adviser. The cost of a raffle ticket is priced at (1) ticket for one hundred (\$100.00) U.S. Dollars.

All winners must meet the eligibility requirements set forth in these rules in order to qualify for the prize. The number of entries will be limited to 350 and no additional entries will be accepted once that limit is reached.

**ENTRY SCHEDULE:** The **American Legion Riders Post 91 “16<sup>th</sup> Annual ALR 91 Motorsport Raffle”** Entries will be accepted starting September 15, 2024 until 1:59 PM Arizona Time, on Saturday December 14, 2024 or until the limit of 350 entries is reached, whichever comes first.

**ODDS OF WINNING:** The actual odds of winning will be based on the actual number of entries received, with a maximum of 350 entries.

**RANDOM DRAWING:** The first drawing will be to identify the Grand Prize winner of the “16<sup>th</sup> Annual 2024 ALR 91 Motorsport Raffle. The winner will be selected at a random drawing to be held on Saturday, December 14, 2024, at approximately 2:00PM Arizona Time at Ride Now Chandler. Remaining prizes are as follows: (2) \$1000, (2) \$500, (4) \$250, and (15) \$100. Drawings will take place at Wayne V. McMartin American Legion Post 91, located at 922 N. Alma School Rd, Chandler AZ, 85224, at approximately 4:00PM Arizona Time. The “Winner” of the Grand Prize and all remaining prizes will be notified in person (if present), by phone and/or email address provided by the winner on their entry. The American Legion Riders will make reasonable efforts to contact the winner. The winner and their eligibility will be verified by an American Legion Riders Post 91 officer. **The Grand Prize winner will be allowed up to 30 days to notify American Legion Riders Chapter 91 of the choice of either the \$10,000 check or the \$15,000 credit at RideNow Powersports (AZ) for a new or used vehicle of choice. Winning tickets are non transferable. The winner will forfeit the prize at the end of 30 days if American Legion Riders Chapter 91 has not been notified of the choice of the Check for \$10,000 or \$15,000 credit at RideNow Powersports (AZ) for a new or used vehicle of choice.**

**PRIZES:** The first (1<sup>st</sup>) place prize will be either a check for Ten Thousand U.S. Dollars (\$10,000.00) or a credit up to Fifteen Thousand U.S. Dollars (\$15,000.00) at RideNow Powersports or one of three Harley Davidson dealerships owned by RideNow Powersports. Arizona locations only. For the purchase of a motorsport vehicle of choice. Restrictions and availability apply. The credit may be used for the purchase of the motorsport vehicle of choice “as-is”. The credit does not include and may not be used for any taxes, licensing, title, insurance, shipping, dealer costs and/or ANY additional upgrades. All federal, state, and local income taxes, insurance, licensing, registration, title fees, shipping, dealer costs and/or ANY additional upgrades connected to the prize are the responsibility of the “winner”. If the Motorcycle is chosen it must be purchased at a RideNow Powersports or one of three Harley Davidson dealerships owned by RideNow Powersports in Arizona. Legion Riders Post 91 's use of their name, photograph and/or likeness, address, voice and statements made by or attributed to them, in perpetuity, in any and all media no known or hereafter developed (including without limitation, print, broadcast, social and Internet) for legitimate business purposes, including advertising and promotional activities, without additional compensation unless prohibited by law.
